The Deputy Director, Nandankanan Zoological Park, PO: Baranga invites sealed tender in prescribed form from interested registered MSME units for supply of Double Galvanized Chain link mesh of the specifications and quantity as mentioned below:

**Tender Papers reaching the office of the undersigned beyond the scheduled time & those without sealed cover shall not be accepted.**

The sealed covers containing the tender papers received within the scheduled time shall be opened on 11.00 AM of 18.09.2021 in the Conference Hall of Nandankanan Zoological Park. Either the tenderer or his authorized representative should remain present at the time of opening of the tender.

The following documents shall be enclosed with the tender paper failing which the tender shall not be entertained and will be liable for rejection being non responsive.

1. i. Tender form can be obtained from the website of Nandankanan Zoological park [www.nandankanan.org](http://www.nandankanan.org) and submitted with a Bank Draft of ₹.11800/- (Rupees Eleven thousand eight hundred) only inclusive of 18% GST in favour of the Deputy Director, Nandankanan Zoological Park in any Nationalized Bank payable at Bhubaneswar towards cost of tender paper cost. The cost of tender paper is not refundable under any circumstances.
- ii. Bid Security Declaration in shape of an affidavit be made to the Deputy Director, Nandankanan Zoological Park in pursuance of provision laid out under Rule-171 of General Financial Rules, 2017. Government of India and communicated by Government of Odisha Finance Department Office Memorandum No. 8943/F dated 18.03.2021 that "if he withdraw or modify his bids during period of validity etc. shall attract 03 years ban from participation in any



*tender in Nandankanan”.*

  - iv. Copy of GST registration certificate and copy of monthly return Acknowledgement for the month of July,2021 or onwards
  - v. Detailed address of the tenderer with contact number supported by Satisfactory proof (copy of Voter Identity card / Adhar Card / Driving license /Telephone / Electric bill for the month of June / July,2021 or letter / copy of Front page Bank Pass Book along with last six months transaction with photograph on Pass Book .The documents are to be self attested.
  - vi. An affidavit by the tenderer declaring that the documents submitted by him are true to the best of his knowledge and in case any thing contrary arises in future, the tender shall remain solely liable for rejection.
  - vii. Tender papers without signature of the tenderer or incomplete in any manner shall not be entertained & shall be liable for rejection.
  - viii. Registration Certificate from DIC/EPM/NSIC etc.( if tenderer intends to claim benefits of MSME)
  - ix. Previous supply order to Government agency, if any(optional)
2. The tenderer shall submit sample of the materials of size **1'x1'** alongwith tender paper duly sealed. The sample submitted may be tested by the undersigned in approved laboratory. The chain link mesh to be supplied should confirm to **IS-2721** or similar standard as per test report. The tenderer will submit the sample of all those specifications for which tenderer wish to supply. Submission of sample material of size 1"x1" alongwith tender paper is mandatory . The bid will not be compared for those specification whose sample has not been submitted by the tenderer.

**The following terms and conditions shall be applicable for the tender:**

3. Form of Tender: The tender form will consist of two parts, (i) Form-A (Technical) and (ii) Form-B (Financial). The Tenderer has to give details of clause-1 i.e. (I to ix) in Form-A (Technical). In Form-B the tenderer has to quote financial amount only. Form-A & Form-B are to be kept in two different sealed covers over which it has to be written clearly Form-A / Form-B respectively. Both covers should be kept in a envelope super scribing "SUPPLY OF DOUBLE GALVANIZED CHAINLINK MESH TO NANDANKANAN ZOOLOGICAL PARK DURING, 2021-22 and the name of the tenderer. Otherwise tender will not be considered. The tender should be sealed and complete in all respect.
4. ***The price quoted should be per sq.mtr and inclusive of all charges, taxes and delivery at Nandankanan Zoological Park***

5. Payment shall be made after testing the quality of random sample taken random from the delivered lots in the approved laboratory as per the aforesaid specification & on completion of delivery. The supply order may be placed in one or more phases as per requirement.
6. As per the guide line of the Income Tax Department TDS as per the applicable rate shall be deducted from the supplier at the time of payment.
7. The successful tenderer shall be required to enter an agreement with the undersigned for timely supply of the materials upon placement of order for a reasonable period failing which penalty / cancelation of supply order will be issued. The successful tenderer shall also be required to furnish a deposit of 3% of total order value to the undersigned named 'Performance Security' in shape of Bank Draft of a Nationalized Bank payable at Bhubaneswar to be pledged with the undersigned for faithful discharge of the agreement.
8. The period of tender may be extended for **one more year**, if the tenderer supply the material of appropriate quantity and timely supply, this extension will be on mutual consent and on same cost of material. Price preference including additional price preference for the micro, small & medium Enterprises / vendors registered in Odisha may be given during financial bid consideration.
9. Nandankanan authority reserves the right to accept or reject any or all tender papers without assigning any reason thereof.
10. Nandankanan authority reserves all right to alter any of the terms and conditions as deemed proper in the interest of the Govt.
11. Any legal dispute that may arise in future shall be subject to the jurisdiction of the SDJM, Bhubaneswar only.
