TERMS AND CONDITION FOR SUPPLY OF LABORATORY CHEMICALS, GLASS & PLASTIC WARES FOR THE FINANCIAL YEAR, 2025-26 FROM REPUTED DISTRIBUTOR/STOCKISTS / FIRMS FOR THE USE IN THE CENTRE FOR CONSERVATION RESEARCH AND TRAINING, NANDANKANAN ZOOLOGICAL PARK FOR RESEARCH & DIAGNOSTIC PURPOSE.

- 1. The tenderers must submit the rates for the supply of laboratory chemicals, glass and plastic ware for the stipulated time period from reputed Companies / Multi- National companies/Distributor/Stockiest for the use in the Centre for Conservation Research and Training, Nandankanan Zoological Park (CCRT) for research and diagnostic purpose. Taxes shall be as per Govt. rules in force. The rate should be quoted without any other condition. All items should be delivered at CCRT at the cost of contractor.
- 2. The period for supply of laboratory chemicals, glass and plastic will be for the financial year, 2025-26. The highest offered discount for the laboratory chemicals should be submitted in the sealed envelope in the prescribed proforma latest by 13.10.2025 upto 5.00 P.M.
- 3. The tenderer shall furnish the following documents with technical Bid
 - a) Earnest Money Deposit (E.M.D) for Rs.12,500/- (Rupees Twelve thousand Five hundred only) should be deposited in shape of Bankers Cheque/ Demand Draft drawn in favour of "Society for Management & Development of Nandankanan Zoological Park" in any scheduled Bank payable at Bhubaneswar. Tender papers without E.M.D shall not be considered and liable for rejection. EMD value shall not be adjusted towards previously available amount / Security Deposit / Bill with Deputy Director, Nandankanan Zoological Park.
 - The Govt. of India / State Govt. Deptt. or undertakings may apply for exemption of EMD with an undertaking. The EMD of all the unsuccessful bidders shall be returned after finalization of all the process of tender. No interest on Earnest Money Deposit will be paid.
 - b) A recent passport size colour photograph (not Polaroid one) duly signed in front by the tenderer and to be pasted in the space given on Form-A (Technical Bid)

m) Technical bid and financial bid should be kept in separate envelope duly sealed and both bids should be kept in one envelope duly sealed addressed to the Deputy Director, Nandankanan Zoological Park, Bhubaneswar and detailed address of tenderer should be mentioned in the envelope.

n) Demand Draft/Pay Order/Banker's Cheque obtained earlier than the date of advertisement inviting bids for supply of laboratory chemicals, glass and plastic ware to the Nandankanan Zoological

Park, will not be accepted.

- 4. The successful tenderer shall enter into an Agreement with the Deputy Director prior to supply of medicine. The successful tenderer shall be required to submit the Security Deposit (S.D) 10% of the quoted value as Security Deposit (S.D) amounting maximum upto Rs.50,000/-(Rupees Fifty Thousand only) in shape of Bank Draft / Demand Draft drawn in favour of "Society for Management & Development of Nandankanan Zoological Park" in any Nationalized Bank payable at Bhubaneswar. After completion of agreement period with satisfactory performance—the security deposit amount will be returned without interest. In case of any breach of terms and conditions or unsatisfactory performance or other lapses, the security deposit would be forfeited to Government. The decision of the Deputy Director, Nandankanan Zoological Park would be final and binding on this matter.
- 5. If the discount price offered is tied between the bidders, then it will be decided by lottery system only.
- 6. The tenderer has to supply of laboratory chemicals, glass and plastic ware immediately to the Center for Conservation Research and Training (CCRT) Nandankanan Zoological Park as and when requisitioned for as per the direction of Biologist, Nandankanan Zoological Park. No transportation charges shall be given for the same. The supply may be for more than one or two times a day as per the need/emergency situation. The indented medicines should be supplied to CCRT latest by 15 (fifteen) days positively.
- 7. The Deputy Director, Nandankanan Zoological Park may cancel the tender at any time without assigning any reason.
- 8. The Deputy Director, Nandankanan Zoological Park, Bhubaneswar at any time by notice in writing can terminate the contract without any compensation if the contractor commits any breach of the contract. Deputy Director, Nandankanan Zoological Park, Bhubaneswar reserves the right to impose monetary penalty at his discretion the extent of average monthly contract value on each occasion or actual loss occurred to Government whichever is higher.
- 9. He shall be personally responsible for retaining and safe custody of the supply of laboratory chemicals, glass and plastic ware requisitioned from this office until the same handed over to the CCRT Nandankanan Zoological Park Section. Any claim of lose / lost compensation etc. shall be paid by him and the Nandankanan Zoological Park will not be responsible to the above.
- 10. The Tenderer has to execute an agreement in the non-judicial stamp paper of Rs.100/- per forma to be furnished by Nandankanan Zoological Park in India.
- 11. All powers in awarding contract in relaxation of any eligibility criteria lies with the Deputy Director, Nandankanan Zoological Park.
- 12. The Deputy Director Nandankanan Zoological Park shall have all the right to reject / accept any tender without assigning any reason.
- 13. Any clause of the tender can be cancelled / modified / altered during the course of the tender / period of work at the discretion of the Deputy Director, Nandankanan Zoological Park and the tenderer shall have to accept the altered or modified condition.
- 14. Chemicals includes Chemicals/Solvents (LR/AR/HPLC Grade), Rare Chemicals/Fine Chemicals, Molecular Biology Enzymes, Reagents & Kits / Biochemicals / Immunochemicals, Readymade media,

- Glass wares including the complete range, Plastic wares (complete range including liquid handling product), disposable safety wears, Oligos & Sequencing Services includes Oligos Synthesis, Gene Synthesis, Gene Sequencing & Analysis, Genome & Metagenomic Sequencing Analysis etc.

- 17. An undertaking may be given that the price list being furnished with the proposal will remain valid for the current rate contract irrespective of validity period.

PENALTY

If the contractor commits any breach of this contract, he shall be liable to be fined upto an amount not exceeding 1/4th of the contract value for every act of default or negligence. On demand, the amount should be deposited within 10 days. The Deputy Director, Nandankanan Zoological Park reserves the right to cancel the contract within 15 days of the notice period.

PEROD OF CONTRACT

- A. The contract will be for a period of the financial year, 2025-26.
- B. Under no circumstances the contractor will be allowed to leave before the completion of the contract.
- C. In the event of contractor leaving before completion of contract period the security deposit will be forfeited.
- D. The validity period of the present tender is for the financial year, 2025-26, but it can be extended on the same approved rates at the discretion of Deputy Director, Nandankanan Zoological Park on the satisfactory performance of the contractor.

START OF THE OPERATION

- I. The successful tenderer shall have to start the supply of laboratory chemicals, glass and plastic wares as per the requisition of CCRT from 15 days from the first monthly requisition, positively.
- II. If the same rate is offered by more than one tenderer then the Deputy Director, Nandankanan Zoological Park immediately after opening such tenders will permit those tenders who are present and who have offered one and the same rate to increase their offer and the highest offer so increased will be considered for acceptance, or otherwise in case there is a refusal to increase the offer or in the absence of respective

- tenders, the tenders which are to be considered for acceptance will be decided by drawing lots.
- III. The act of the submission of the tender shall be deemed to be as unreserved acceptance of all condition herein contained.

IV. The amount of loss, penalty, compensation, interest etc, if not paid within a period of 15 days from the date of demand, shall liable for forfeiture of security.

LOSS TO NKZP

In the event of any loss to the Nandankanan Zoological Park on the account of any act of commission or omission by the contractor's employees, the contractor shall make good the loss suffered by Nandankanan Zoological Park either by replacement or by payment of adequate compensation as decided by the Deputy Director, Nandankanan Zoological Park.

JURISDICTION OF COURTS

- I. All disputes shall be subject to the jurisdiction of courts in the Bhubaneswar
- II. The Deputy Director, Nandankanan Zoological Park reserves the right to accept or reject any tender without assigning any reason thereof.
- III. The Deputy Director is not bound to accept the highest tender. He reserves the right to accept highest or the lowest tender at his own discretion.

EARNEST MONEY DEPOSIT (E.M.D)

- I. All bidders shall have to deposit earnest money of Rs. 12,500/- (Rupees Twelve thousand Five hundred only) in the form of a Demand Draft payable in the name of the "Society for Management & Development of Nandankanan Zoological Park", Bhubaneswar from a Nationalized/scheduled bank along with their Bid application inside the envelope.
- II. Demand Draft/Pay Order/Banker's Cheque issued earlier than the date of advertisement inviting bids for supply of laboratory chemicals, glass and plastic wares to the Nandankanan Zoological Park, will not be accepted.
- III. Earnest money shall be refundable to the unsuccessful bidders within one month of the award of allotment letter. The bidders have no right to demand interest on the Earnest Money. However, the successful bidder's earnest money shall be returned only once the successful bidder has deposited the security deposit.
- IV. However, in case where the bidder withdraws or modifies the bid during the 100 days validity of the bid or it has come to the knowledge that bidder has used fraudulent practices for this bid, the earnest money shall be forfeited.
- V. Tender received without EMD will be rejected summarily.

TERMINATION OF THE CONTRACT

- a. The Deputy Director, Nandankanan Zoological Park can terminate the contract at any time after serving two weeks' notice to the contractor for breach of any condition of the contractor if during the period of the contract, the performance is not found satisfactory.
- b. The decision of the Deputy Director, Nandankanan Zoological Park shall be final and binding on the contractor in this regard.
- c. Failure by the contractor to comply with any statutory requirements during the period of the contract shall result in the termination of the contract and subsequent disqualification for participation in any future tender in the Nandankanan Zoological Park.

d. The contractor will not be allowed to leave the contract before one year failing which the contract will be terminated and the performance security will be forfeited. Failure by the contractor to comply with any statutory requirements and terms of the agreement during the period of contract shall result in termination of the contract forthwith and subsequent disqualification of the contractor for participation in any future tender at the Nandankanan Zoological Park. The security deposit will also be forfeited.

RENEWAL OF THE CONTRACT

- i. The period of the contract will be for the financial year, 2025-26.
- ii. The contract can be extended beyond 31.03.2026 subject to satisfactory performance.
