**TERMS AND CONDITIONS**

1. Sealed E.O.I's in prescribed Form are invited from interested TRAVEL AGENCIES /TOUR OPERATORS/Animal transporters for providing of two vehicle to Nandankanan Zoological Park for transportation of live animal from **Indore Zoo of Madhya Pradesh & Aizawl Zoo of Mizoram** to Nandankanan Zoological Park for the year 2020-21.
2. The sealed E.O.I should be addressed to Deputy Director, Nandankanan Zoological Park, PO: Barang Dist: Khordha PIN-754005 and superscribed "Quotation for providing of vehicles to Nandankanan" at the top left hand corner of the envelope and to be submitted by Regd. Post/Speed post/ Courier/by hand so as to reach the office of the undersigned on or before **4.30PM of 07.12.2020**
3. The application form along with terms & conditions shall be available in the website of Nandankanan Zoological Park ([www.nandankanan.org](http://www.nandankanan.org)) **from 11.00 AM of 04.12.2020 onwards.**
4. The sealed E.O.I will be opened at **03.00 PM of 08.12.2020** in the office of the Deputy Director, Nandankanan Zoological Park by the sub-committee headed by the Deputy Director in presence of the applicants or their authorized representatives.
5. E.O.I received beyond the schedule time will not be considered. Once opened, no E.O.I persons will be allowed to withdrawn from the process till its finalization.
6. The E.O.I should be accompanied with the following documents:
  - a. Passport size photograph.
  - b. EMD for **₹.5000/-** in shape of Demand Draft/ Bank Draft drawn in favour of Deputy Director, Nandankanan Zoological Park on any Nationalized Bank payable at Bhubaneswar.
  - c. Self attested copies of following documents must be attached along with application.
    - i. Copy of the PAN Card
    - ii. Copy of the Votor ID
    - iii. Address proof (Telephone /electric bill)
    - iv. Copy of GST Registration Certificate

**The E.O.I without aforesaid documents shall be liable for rejection.**

7. The price to be quoted must include all the incidental charges exclusive of Tax.
8. The successful interested person shall provide vehicles to Nandankanan at his own cost. To and Fro charges from his station to Nandankanan shall be paid by Nandankanan
9. The successful interested person should provide vehicles to Nandankanan on the date after 08.12.2020 as per the date decided by the Nandankanan Committees and letter will be issued from Nandankanan authority. Report the vehicle before the Range Officer, Sanctuary Management Range. In case of failure to provide vehicles on the stipulated time, the EMD shall liable to be forfeited. No claim what so ever shall be entertained thereafter.



10. The vehicle will move from Nandankanan Zoological Park after loading empty transportation crates to the destination as about which may taken around 7 to 8 days.
11. The successful intended persons should provide the passenger vehicle to Nandankanan as per prior intimation by the Nandankanan Authority.
12. The 50% payment will be made in advance on the date of transportation for fuel expenses and balance payment shall be made after completion of transportation.
13. The successful intended persons should submit the vehicle information for transport vehicle & passenger vehicle separately to the Range Officer, Sanctuary Management on 09.12.2020 at 11.30AM
14. The bid amount for transport vehicle and passenger vehicle shall be treated separately.
15. The vehicle should not be more than three years old and have roadworthy, valid national permit & all other statutory legal documents.
16. The driver of the vehicle should be well behaved, gentle & obedient and must have valid Driving License.
17. If required, the vehicle may play en-route during night time.
18. The authority reserve the rights to accept or reject any or all quotations without any reason thereof.
