TERMS AND CONDITIONS FOR RENOVATION OF GLASS HOUSE AND GREEN HOUSE AT STATE BOTANICAL GARDEN

- Sealed EOI in prescribed Forms is invited by the Deputy Director, Nandankanan Zoological Park, Barang from the interested individuals/ Firms/ agencies/ companies for renovation of Glass House and Green House at State Botanical Garden for the year 2021-22.
- 2. Form of EOI: The EOI form will consist of two parts, (i) Form-A (Technical) and (ii) Form-B (Financial). Form A (Technical) & Form B (Financial) are to be kept in two separate sealed covers over which it has to be written clearly "Form-A" / "Form-B" as the case may be and both the covers should be kept in a single sealed cover super-scribing "EOI for renovation of Glass House and Green House at State Botanical Garden for the year 2021-22" and the name of the Bidder or else EOI shall not be considered. Form "B" contents in two parts i) Renovation of Glass House ii) Renovation of Green House and the rate should be quote accordingly. The EOI should be sealed and complete in all respect.
- 3. The EOI forms along with terms & conditions can only be obtained / downloaded from the website of Nandankanan Zoological Park (www.nandankanan.org).
- 4. The EOI should be addressed to the Deputy Director, Nandankanan Zoological Park, PO: Barang Dist: Khordha PIN-754005 and dropped in EOI box / submitted by registered post so as to reach the office of the undersigned by 05.00PM of 15.02.2022.
- 5. The sealed EOI will be opened at 03.30 PM on 16.02.2022 in the Conference Hall of Nandankanan Zoological Park in presence of the EOI opening committee under chairmanship of Deputy Director, Nandankanan Zoological Park in presence of the Bidder or their authorized representatives.
- 6. EOI received beyond the schedule date & time will not be considered. Once opened, no Bidder will be allowed to withdraw till finalization of the bidding process.
- 7. The successful bidder should follow all the prevailing labour rules & regulations by the Govt. of Odisha / Got. India.

- 8. The EOI should be accompanied with the following documents:
 - A. Passport size photograph of the bidder.
 - B. EMD for Rs.20,000/- in shape of Demand Draft drawn in favour of Deputy Director, Nandankanan Zoological Park on any Nationalized Bank payable at Bhubaneswar.
 - C. Self attested copies of following documents must be attached along with application:
 - I. Copy of the PAN Card
 - II. Copy of the Aadhar Card
 - III. Income Tax Clearance Certificate.
 - IV. Copy of GST Registration Certificate
 - V. Copy of MSME certificate if claimed for exemption of EMD.
 - D. Valid labour license certificate under contract labour (Regulation and abolition) Act, 1970 / DIC License holder certificate.
 - E. Proof of being a registered man-power service provider in the related field with Valid Registration Certificate of the firm / Society / entrepreneur / Company.
- Preferences will be given for credibility and experience certificate issued from any related concerned Authority / Employer of a Govt. / ULB / PSU of repute with a minimum period of 02 (Two) years for the works of similar nature.
- 10. The EOI without related documents shall be liable for rejection.
- 11. The bidder / agency will **quote the rate** for the renovation of Glass House & Green House as per the scope of work mentioned in Para No.33 at State Botanical Garden. The rate to be quoted inclusive of all taxes & other incidental charges and shall be both in figures & words as per the format specified in Financial Bid (Form- "B-I" & "B-II").
- 12. After finalization of the bidder, the successful Bidder / Agency shall be required to be made an agreement with the Deputy Director. Nandankanan Zoological Park.
- 13. The term 'Deputy Director' wherever mentioned in the document of Agreement shall mean the "Nandankanan Biological Park" authority. The term "Agency" wherever mentioned in the document shall mean the party selected for award of the contract. The term "Contract" means the agreement between the "Deputy Director" and "Agency" which would be signed at the time of awards the work assignment.

14. The EMD shall subject to forfeiture in the following cases:

- a. In case the successful bidder withdraws from the EOI after opening of his bid.
- b. In case the successful bidder does not come forward to sign the agreement within the stipulated time period by the Deputy Director.
- 15. The EMD of successful bidder shall be only returned after successfully completion of the bidding process.
- 16. The successful bidder or his authorized agent for the work has to in contact with the Range Officer, State Botanical Garden for completion of work in time.
- 17. A security deposit in the form of Bank Draft amounting to **Rs.25,000/-** drawn in favour of Deputy Director, Nandankanan Zoological Park on any Nationalized Bank payable at Bhubaneswar shall be submitted on or before the execution of agreement. The successful bidder in the event of any unwanted occurrence or breach of contract the compensation as assessed by the undersigned shall be recovered from his security deposit.
- 18. During the period of contract the successful bidder shall provide uninterrupted service with diligently, honestly and to the satisfaction of the Deputy Director / authorities of Nandankanan Biological Park.
- 19. The successful bidder shall be entirely responsible regarding genuineness and identity of the workers engaged by him and should provide ID proof during Renovation work inside State Botanical Garden.
- 20. The renovation work of Glass House and Green House at State Botanical Garden should be completed before 20.03.2022 positively. The completion of the work as per agreement should be jointly signed and handed over to the Range Officer, State Botanical Garden.
- 21. If the Successful bidder fails to perform his Renovation work at State Botanical Garden under scope of work at para **No.33** on or before **20.03.2022**, the proportionate payment for the renovation work shall not be considered / forfeiture of the Security Deposit as per recommendation of Range Officer, SBG and Asst. Conservation of Forest, SBG for deviation of quality / quantity of the works.

- 22. The Security Deposit will be refunded after two months of completion of work.
- 23. The successful bidder / agency shall pay all taxes to the Govt. in accordance with the existing Acts, Rules, notification and regulations. T.D.S will be deducted as per prevailing rules.
- 24. It is not binding on the part of the authority to accept the lowest bidder and Deputy Director, Nandankanan Zoological Park reserves all the rights to reject any or all the bidders without assigning any reason thereof.
- 25. An undertaking from the Bidder indicating that he has not been black listed by any government department or any organization in India for participating in EOI previously.
- 26. The duly filled technical bid along with supporting documents must be submitted in hard copy in time.
- 27. The original bid document dully signed and stamped on each page as a token of acceptance of terms & conditions of the bid document
- 28. In case any dispute arising between the Deputy Director and the contractor as the matter arising under this contract such dispute shall be referred to the Director of Nandankanan Biological Park, Bhubaneswar within one week from the date of dispatch of the order by registered post acknowledgement due and his decision thereon shall be final.
- 29. The Deputy Director, Nandankanan Zoological Park has the right to annul, add, and modify any of the terms & conditions above without any notice in the interest of public.
- 30. Canvassing in any other form relating to the bidder is strictly prohibited and the bid submitted by the bidder who resorts to canvassing will be liable for rejection. The bids which do not fulfill any or all of the conditions or incomplete in any respect and incorporating additional conditions other than the conditions as mentioned herein are liable for rejection.
- 31. All Appeals shall be made to the Director of Nandankanan Biological Park, Bhubaneswar whose decision thereon shall be final.
- 32. All disputes those may arise in future shall be subject to the jurisdiction of the SDJM, Bhubaneswar only.
