Sealed EOI are invited from persons/firms for disposal of approximately 7(Seven)Tons of Waste Buffalo Bones of Nandankanan Zoological Park for the year 2024-25. The sealed EOI should be addressed to the Deputy Director, Nandankanan Zoological Park, PO: Barang Dist: Khordha PIN-754005 and superscribed "**E.O.I for disposal of Waste Buffalo Bones of Nandankanan for the year 2024-25**" at the top left-hand corner of the envelope and to be submitted by Hand/ Regd. Post/Speed post/ Courier etc. so as to reach the office of the undersigned by **5.00PM of 20.01.2025**. EOI received beyond the schedule time will not be considered. Once opened, no tender will be allowed to be withdrawn till finalization of the tender process.

The E.O.I will be opened on **21.01.2025** at 03.30 PM in the office of the Deputy Director, Nandankanan Zoological Park in the presence of the sub-committee headed by the Deputy Director and the tenderers or their authorized representatives.

1. The E.O.I should be accompanied with the following documents;

- a. EMD for Rs **.10,000/-** (Rupees Ten Thousand only ) in shape of Demand Draft drawn in favour of Deputy Director, Nandankanan Zoological Park on any Nationalized Bank payable at Bhubaneswar.
- b. Copy of the PAN CARD.
- c. A recent passport size coloured photo graph duly signed by the tenderer to be pasted in the space given on the front page of the Tender Paper.
- d. A copy of Voter Identity card/ Driving license/Telephone bill / **Electric Bill** / Aadhar Card for the month of November,2024 as proof of identity.

**The E.O.I without aforesaid documents shall be liable for rejection.**

2. The bidder is required to quote the rate of waste buffalo bones **per annum** inclusive of collection and weighing charges in figure and words. Over written figures will be treated as invalid. The successful bidder would deposit a security deposit 10% of the bid amount in shape of demand draft within 7(Seven) days of finalization of tender.
3. The removal of the bones shall be once in 7 (Seven) days to prevent foul smell & flies incidence. The tenderer is to deposit the cost of bones within 7 days of lifting of the bones through Bank Draft with Range Officer Revenue. The Bank Draft should be drawn in favour of Deputy Director, Nandankanan Zoological Park payable at Bhubaneswar.
4. Because of foul smell associated during carriages, Monday shall be the preferred day for the removal when the zoo remains closed for visitors.
5. The bidder should clean the pits after completely lifting of the materials without dumping anywhere else.
6. Any amount spent for collection , weighthment and cleaning shall be borne by the tenderer.

7. The bidder should completely remove the materials from the designated pit. To prevent residual infection, the tenderer should remove all the bones in the pit and in its surroundings. After each cleaning, the bone pit shall be disinfected by Zoo Veterinarians/ Range Officer, Sanctuary Management Range.
8. The persons and vehicles, which shall be engaged for removal shall be authorized by the Range Officer, Security & Maintenance Range.
9. The entry and exit of the vehicle shall be reflected in the register maintained at entrance gate (Eastern side) of the Zoo.
10. Date of proposed lifting will be intimated to the Range Officer, Sanctuary Management Nandankanan from time to time. The bones lifted should be weighed in presence of the staff of Range Officer, Sanctuary Management and should be recorded in the register maintained at the Range.
11. No further extension of time will be allowed for the unlifted bones after **31.03.2025**.
12. The certification of Zoo Veterinarians regarding nature of bone shall be mandatory.
13. The undersigned shall have the right to stop lifting of the Waste Cattle Bones and termination of the tender at any time without assigning any reason and the E.M.D shall be returned.
14. The authority reserves all right to accept or reject the tender without assigning any reason thereof.
15. EMD of unsuccessful bidders would be returned after completion of the tender process.
16. The dispute/ litigation that may arise, if any, shall be subject to the jurisdiction of the court of S.D.J.M, Bhubaneswar only.
