1. **An earnest money of Rs.11,550 /- (Rupees Eleven Thousand Five Hundred Fifty only)** must be deposited in the form of Cheque / DD payable to **"Deputy Director, NANDANKANAN ZOOLOGICAL PARK"** payable at **Bhubaneswar**. The particulars of the earnest money deposited must also be mentioned on the top of the envelope by indicating the cheque / draft / pay order number and date, failing which the Tenders will not be opened. The agencies which are exempted from submission of EMD, should enclose a valid exemption certificate to this effect. The Tenders will not be considered if earnest money / exemption certificate is not deposited with the Tenders. The EMD shall be refunded to the unsuccessful firm without paying any interest by the Nandankanan Zoological Park.

2. The firm is being permitted to tender in consideration of the stipulations on his/her part that after submitting his/her tender, he/she will not withdraw from his offer or modify the terms and conditions thereof. If the firm fails to observe and comply with the foregoing stipulation the aforesaid amount of EMD will be forfeited by the Nandankanan Zoological Park. In the event of the offer made by the firm not being accepted, the amount of earnest money deposited by the firm will be refunded to him after he has applied for the same, in the manner prescribed by the Nandankanan Zoological Park.

3. Nandankanan Zoological Park reserves the right to reduce or terminate the contract or to extend its coverage in the interest of the Nandankanan Zoological Park, for any justifiable reasons, not mandatory to be communicated to the Tenderer. Decision of the Deputy Director will be final for any aspect of the contract and binding to all parties. Disputes arising, if any, on the contract will be settled at his / her level and will not be referred to arbitration.

4. Acceptance by the Nandankanan Zoological Park will be communicated by email/ fax/ letter or any other form of communication. Formal letter of acceptance and work order of the Tenders will be forwarded as soon as possible, but the earlier instructions in the email/ fax / letter should be acted upon immediately.

5. No interest on security deposit and earnest money deposit shall be paid by the Nandankanan Zoological Park to the tenderer.

6. GST or any other tax on material in respect of this contract shall be payable by contractor and Nandankanan Zoological Park will not entertain any claim whatsoever in this respect. However, the TDS or any other tax which is as per the rules of the Govt. of India, shall be deducted at source from bills of the successful tenderer, as per rule.

7. The contract is governed by terms and conditions laid down in work order and is terminable with 1(one) month notice on either side.

8. Firm should enclose all Relevant / Essential Documents in technical bid. The financial bid should be in supplied format only. 1. The contractor shall not transfer or sub-contract the tender under the contract to anyone else.
2. The agency shall employ good and reliable persons with robust health. In case any of the personnel so provided is not found suitable by the Nandankanan Zoological Park, the Nandankanan Zoological Park shall have the right to ask for his replacement without giving any reason thereof and the agency shall on receipt of a written communication will have to replace such persons immediately.
3. The agency shall be wholly responsible for paying remuneration and other admissible allowances to the persons as engaged by them and Nandankanan Zoological Park shall in no way be responsible for meeting any kind of expenditure to these persons.
5. The successful tenderer will have to use the quality material and tools & equipment at its own cost.
6. The Nandankanan Zoological Park shall not directly or indirectly employ any person of the agency during the period of contractor thereafter under any circumstances. The terms and Conditions of the Contract schedule are as follows:

1. This contract shall come into force from the date of acceptance of offer by the successful bidder and will remain in force for a period of two months but can be terminated by Deputy Director, Nandankanan Zoological Park by giving one calendar months' notice in writing of its intentions to terminate the contract. The contract can be renewed, on mutually agreed terms.
2. The firm will provide full particulars of every worker deployed by it on site for providing the services.
3. All personnel posted at premises shall all times and for all purpose be deemed to be employee of the firm and the Nandankanan Zoological Park shall have no liability on this account in any manner.
4. The Deputy Director, Nandankanan Zoological Park / authorised officer shall have the right to ask for the removal of firm worker/representative considered by the council to be incompetent, disorderly or any other reason and such person shall not again be deployed without the consent of the Nandankanan Zoological Park.
5. The firm will raise a bill of this amount after completion of the work and the payment released by the Nandankanan Zoological Park in the form of crossed cheque / online payment to the firm subject to satisfactory performance / delivery of contracted job / work / services.
6. The deduction of income tax (TDS) from the bills of the agency will be made at source as per rates applicable from time to time.
7. In case of dispute between the parties, the matter shall be referred to Deputy Director, Nandankanan Zoological Park. The decision of the Deputy Director, Nandankanan Zoological Park shall be final and binding in any respect of any dispute between the parties.
8. That the firm shall ensure the successful implementation of the terms and conditions of the agreement by proper control and supervision of the work.

That the firm agrees to discharges all their legal obligations in respect of their workers in respect of their wages and services conditions and shall also comply with all the rules and regulations and provisions of law in force that may be applicable to them from time to time, viz. obligations under Contract labour (Regulation & Abolition) Act, 1970, workmen's Compensation Act, 1943, E.P.F., E.S.I. & M.P. Act, 1947 etc. Firm agrees to indemnify and keep indemnified the council on account of any failure to comply with the obligations under various law or damage to NASC due to acts/omissions of firm.
11. It is also agreed that under no circumstances, the volunteers and/ or the employees / workmen of the firm shall be treated, regarded or considered or deemed to be treated as the employees of the Nandankanan Zoological Park and the Firm alone shall be responsible for their remuneration, wages and other benefits etc. Firm shall indemnify and keep indemnified the council, against any claim that it may have to meet towards the employees / workmen of the Firm. Firm's employees/ workmen shall have no claim to absorption/ regularization and financial benefits etc. that are admissible to regular employees in the office of Nandankanan Zoological Park.
12. The contract is subject to the conditions that the firm shall comply with all the laws of Central Govt./ State Govt. as applicable relating to this contract.

13. In case of any loss or damage to the property of the Nandankanan Zoological Park which is attributable to the firm, the full damages will be recovered from the firm.

14. The firm shall not transfer its right or sub- contract to anyone else.

15. The firm or its workers shall not misuse the premises allotted to them for any purpose other than for which contract is awarded.

16. The firm shall devote its full attention in service to ensure highest quality in all aspects and discharge its obligations under the contract with trust, diligently and honestly. Any misconduct / misbehavior on the part of the manpower deployed by the agency will not be tolerated and such person(s) will have to be replaced immediately.

17. Incase of any accident / loss of life of the workers during discharging duties compensation to be given to the workers, the same shall be borne by the firm.

18. There will be surprise checking by an Officer of Nandankanan Zoological Park. Shortcomings, if any, pointed out by him/her shall be restored by the contractor within 24 hours of it bringing to his notice.

19. The terms and conditions as stipulated in the tender documents and enclosed herewith, shall be part of the agreement.

20. Liquidated damages clause:

That the contractor shall be responsible for the faithful compliance of the work award order. Any breach or failure to perform the same may result in termination of the work order and forfeiture of the security deposit. An amount of Rs.500 /- will be levied as liquidated damages per day. Whenever and wherever it is found that the work is not up to themark in any point, it will be brought to the notice of supervisory staff of the firm by Nandankanan Zoological Park and if no action is taken within four hours, liquidated damage clause will be invoked. The Deputy Director, Nandankanan Zoological Park reserves the right to reject any of all tenders in whole or in part without assigning any reason therefore. The decision of Deputy Director, Nandankanan Zoological Park shall be final and binding on the contractor/agency in respect of any clause covered under the contract.
